Description of Properties

City Hall – 10,000 SF 2 story office building. Flat and pitched roof Community Development Building – 8,000 sf 1 story office building. Pitched roof Court Services – 12,000 sf 1 story office and court building. Pitched roof Police Department – 10,000 sf 1 story building with numerous offices, holding cells, evidence room, garage, break room, etc. Flat roof.

Ford Center – A complex of 4 buildings with approximately 25-30,000sf. Buildings have pitched and/or flat roofs.

Public Works – 8000sf steel frame office/warehouse with metal roof Linear Park – 500sf park building with 2 restrooms and a concession area, plus electrical service at the workout enclosure

Log Cabin Museum – 1000sf log cabin with pitched roof and crawl space plus 400sf detached garage.

Bodiford House Museum – 2500sf residential style house with pitched roof and crawl space. Estimated age 100 years old.

Scope of the Inspection

Inspection of these properties will include visual inspection of all accessible mechanical, electrical, plumbing, structural, exterior and interior components including the roof, grounds, interior and exterior surfaces, doors, windows and trim, HVAC systems any other systems or items present. Access to all tenant spaces will be necessary as well as to the roof and mechanical room(s). The purpose of the inspection is development of a comprehensive maintenance list to be used by the City of Powder Springs to develop maintenance plans for all city owned buildings. The evaluation of the HVAC systems will be performed by Tom Bunch Heating and Air, Inc.

Length of the Inspection

The physical inspections of all properties are expected to take approximately 65 man hours to complete plus approximately 35 hours for preparing the reports. The inspections will be spread out over a period of time up to 2 weeks.
