

RESOLUTION NO. 2023 - 012

A RESOLUTION ESTABLISHING QUALIFYING FEES AND QUALIFYING DATES FOR THE GENERAL ELECTION TO BE HELD NOVEMBER 7, 2023 FOR THE OFFICES OF MAYOR, AT LARGE POST 1 AND AT LARGE POST 2 OF THE CITY OF POWDER SPRINGS, GEORGIA; AUTHORIZING THE CITY CLERK AND THE CITY ELECTION SUPERINTENDENT TO PUBLISH NOTICES OF QUALIFYING FEES AND OTHER NOTICES REQUIRED OR PERMITTED TO BE PUBLISHED BY THE GOVERNING AUTHORITY IN CONNECTION THEREWITH; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES

WHEREAS, O.C.G.A. § 21-2-131 requires the governing body of counties and municipalities to fix and publish a qualifying fee for each county or municipal office to be filled in the upcoming primary or election; and

WHEREAS, O.C.G.A. § 21-2-131 provides that such fixing and publishing of qualification fees be accomplished prior to February 1 of any year in which a general primary, nonpartisan election, or general election is to be held; and

WHEREAS, under O.C.G.A. § 21-2-131, qualifying fees are set at 3% of the total gross salary of the offices to be filled; and

WHEREAS, O.C.G.A. § 21-2-132 requires municipalities to fix and publish a qualifying period for each municipal office to be filled in the upcoming primary or election; and,

WHEREAS, O.C.G.A. § 21-2-132 provides that such period shall be no less than three and no more than five days and that the days of the qualifying period shall be consecutive; and,

WHEREAS, O.C.G.A. § 21-2-132 provides that municipal qualifying periods shall commence no earlier than 8:30 A.M. on the third Monday in August immediately preceding the general election and shall end no later than 4:30 P.M. on the following Friday;

WHEREAS, pursuant to O.C.G.A. Sec. 21-2-45(c)(1) and consistent with past practice, the City of Powder Springs, Georgia, desires to appoint Cobb County to perform all duties as superintendent of elections;

NOW THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Powder Springs that qualifying fees are hereby set as follows:

For the office of Mayor: \$540.00

For the office of Member of the City Council, At Large Post 1 and Post 2: \$360.00

NOW THEREFORE, BE IT FURTHER RESOLVED by the Mayor and Council of the City of Powder Springs that the qualifying periods for the Offices of Mayor and At Large Post 1 and At Large Post 2 of the City Council are hereby set as follows:


Beginning August 22, 2023, and ending August 24, 2023 between the hours of 8:30 a.m. to

BE IT FURTHER RESOLVED that the City Election Superintendent and City Clerk are hereby authorized to publish any and all notices of qualifying periods and fees, and any other notices required or permitted to be published by the governing authority in connection with upcoming elections.


