# MEMORANDUM OF UNDERTSTANDING

This Memorandum of Understanding (hereafter referred to as "Memorandum") is by and between the following two (2) separate organizations (hereafter referred to collectively as "Partner" or "Partners"):

a. South Cobb Arts Alliance, Inc. (hereafter referred to as "SCAA"), with a principal place of business at 3899 Brownsville Road, Powder Springs, GA 30127 (with a mailing address of PO Box 1037, Austell, GA 30168), a non-profit 501 (3) (c) arts organization;

and.

b. The City of Powder Springs (hereafter referred to as "The City"), with a principal place of business at 4484 Marietta Street, Powder Springs, GA 30127, a city government

for the sole purpose of establishing a working agreement for the SCAA 32<sup>nd</sup> National Juried Exhibit (hereafter referred to as "NJE") at the City's Patricia C. Vaughn Cultural Arta Center (hereafter referred to as the "CAC"). The dates for this event are August 1 through August 27, 2019 with the primary reception and awards for August 10 from 5 to 8pm.

## WITNESSETH

## ARTICLE I -GENERAL PURPOSE

**Section 1.** The City shall provide the CAC for SCAA (its representatives and its artists) to showcase, display, and sell artworks for the NJE, as well as to hold an awards reception and other events, such as panel discussions, during the event show dates with the event open to the public. Use of the building will include the stage, audio visual set up, and some chair and table arrangement as applicable when the final programming is confirmed.

**Section 2**. SCAA shall provide artwork panels, additional lights and other materials to showcase the national and local juried artwork. SCAA will encourage other artists and applicable purveyors, and arts groups to participate in the NJE to support more broadly the goal to reach out to the community to promote SCAA arts programming as well as to promote the CAC venue.

**Section 3**. Partners shall work to support this specific event as well as promote combined holiday programming events in the City.

## ARTICLE II – PARTNER RESPONSIBILITIES

## Section 1. CAC

The City shall maintain any City owned apparatus or equipment, hanging systems, its walls, corridors, the structural and security integrity of the inside and outside of the CAC with the understanding every effort will be made to ensure that the artworks/retail products entrusted to the space during the event will be safe and secure as possible. SCAA shall indemnify and hold harmless the City, its Mayor, City Council Officials, employees and agents, from and against all claims, damages, losses, liabilities, and expenses resulting from use of the City property.

Unless otherwise agreed upon by all parties, for planning purposes, the City shall notify SCAA of any changes in business operation hours, or any other circumstances, which will affect the SCAA event. Operational schedules shall be determined by both Partners.

The City will determine and advise SCAA representatives as to opening and closing procedures to secure the building as well as any other conditions for use of the space, including use of the av system and any other pertinent details.

#### Section 2. South Cobb Arts Alliance

City's name, logo and/or link or location shall be posted on the SCAA social media sites and in related social marketing or event listing promotions regarding the event. Both SCAA and the City may publicize the event and display SCAA pamphlets at the CAC, or at other locations prior to the event.

SCAA will act as the artists' agent including agreements between SCAA and the artist(s) and an inventory of the artwork(s) and items to be located at the CAC. The SCAA agreement with the artist will include the artist's acknowledgement that neither parties are liable for damages or theft, and that the artist will be solely responsible for insuring the artwork against damages or theft.

SCAA will provide to the designated City personnel a listing of opening/closing dates and times for the event including intake/pick up, any additional activities within the event as well as SCAA contact information of primary NJE event volunteers. SCAA understands that its volunteers will be providing facility coverage as no City nor CAC personnel will be stationed at the event.

SCAA reserves the right to arrange the set-up of the event and to include blended experiences for the event with options to include meetings and community centered entertainment during the NJE. SCAA will review these options and work in collaboration with the City to include further expansions with, if applicable, local organizations, schools and/or student performances.

# **ARTICLE III – Marketing and Publicized Materials, including Signage**

**Section 1.** Partners shall jointly discuss outside program signage to be approved by all parties, and shall include both SCAA and City logos as well as electronic signage, if available in order to direct customers to the location.

**Section 2.** Any collateral publications, text, photos, and information posted about or at the location should be agreed upon. Press releases and any other public relations or marketing should be jointly accomplished upon agreement by all Partners.

## Section 3.

Photos of the venue and sample works of arts or events may be taken for public postings for the marketing and archival purposes by SCAA and the City unless otherwise noted by the artist(s).

**Section 4.** Both parties shall be granted limited rights to use the logo or service marks of each other's applicable entities to promote the Event in current or future documents, website or social media, service presentations or grants. If there are any changes to logos, service marks, url and marketing and/or collateral materials, each party, in a timely manner, shall inform the other of such changes.

# **ARTICLE IV – Investment/Revenue**

SCAA will retain a juried entry fee and transaction commission on items sold at the NJE, or other items. The City will not receive any revenue from the sales of any item sold.

## **ARTICLE VIII. Agreement Term**

The term of this Memorandum shall be for one (1) year(s) limited to the 32<sup>nd</sup> National Juried Exhibit beginning August 1 and ending August 27, 2019. Either SCAA or The City may terminate this Memorandum at any time without cause upon sixty (60) days written notice to the other party which will allow SCAA and its artists to remove any and all artwork and fixtures from the City location(s) as well as cancel scheduled programming.

This Memorandum may be amended only with the written consent of all parties. It is understood that all other terms and conditions and any subsequent renewals, amendments and modifications thereto shall remain in full force and effect during the renewal term.
