This firm represents Municipal Communications, LLC concerning the above-captioned Applications. The Applications are scheduled to be considered by you, the Mayor and City Council Members on Wednesday, September 13, 2017 at your regularly scheduled Work Session. Thereafter, the Applications will be heard and considered by you, the Mayor and City Council for final action the following week on September 18, 2017.

The Applications seek allowances from the City of Powder Springs for the construction and ultimate operation and maintenance of a wireless telecommunications tower and related antennae and equipment on a 4.3acre tract of land which is located in your Ward on the east side of New Macland Road north of its intersection with Macedonia Road.

The totality of the subject property is located within a Neighborhood Activity Center ("NAC") and within a Commercial Development Overlay on the City's Future Land Use Map. Municipal Communications' proposal, at the City's behest, has been reviewed and recommended for approval by a Peer Review Consultant ("CityScapes") which the City engaged and recommended for approval on August 28, 2017, the Powder Springs Planning Commission on a vote of 4-1.

The facility planned by Municipal Communications is proposed to include a 170 foot in height multi-tenant monopole tower; ground-mounted communications equipment; and, associated improvements to facilitate operations and access. The carrier located at the top of the

tower will be Verizon Wireless and there will be additional antennae arrays at heights approximately ten feet (10') apart for a number of co-locators recommended by CityScapes and the City's Staff. If approved, the telecommunications tower will include equipment designed to improve 4G coverage and data throughput for Verizon customers along New Macland Road, connecting to Powder Springs Road and Macland Road and all residential areas on both sides of New Macland Road.

Your Professional Staff will be providing you, if they have not already done so, with a full complement of the technical data which both Municipal Communications and CityScapes submitted as well as other information and documentation generated by the Staff.
