

RESOLUTION NO. 2024 – 090

A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE AGREEMENTS WITH INLINER SOLUTIONS, LLC; FEDERAL EC LLC; VORTEX SERVICES, LLC; SITE ENGINEERING, INC.; S.H. CREEL CONTRACTING, LLC; AND WITH HD EXCAVATIONS & UTILITIES LLC FOR ON CALL SERVICES TO PERFORM REPAIRS AND MAINTENANCE TO THE CITY’S STORMWATER SYSTEM; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the Mayor and City Council desires to efficiently and expeditiously make needed repairs and perform necessary maintenance upon the City’s stormwater system, and has set aside funding from its American Rescue Plan Act grant and within its Stormwater Fund for this purpose; and


WHEREAS, the City issued RFP 24-003 to solicit proposals from vendors with experience in performing trenchless repairs of stormwater infrastructure and holding necessary licenses and credentials to perform such work, and opened proposals on May 3, 2024; and


WHEREAS, at the same time the City issued RFP 24-004 to solicit proposals from vendors with experience in performing conventional dig-and-replace repairs of stormwater infrastructure and holding necessary licenses and credentials to perform such work, and opened proposals on May 3, 2024; and


WHEREAS, the Selection Committee reviewed the proposals submitted in response to RFP 24-003 and RFP 24-004 and recommends awarding unit price on call contracts to the three top-ranked firms from each RFP, for a total of six on call contract awards, based on the firms’ qualifications and relevant experience and their quoted unit prices; and

NOW THEREFORE, BE IT HEREBY RESOLVED by the Mayor and Council of the City of Powder Springs that it approves and authorizes the Mayor to execute agreements with Inliner Solutions, LLC; Federal EC LLC; Vortex Services, LLC; Site Engineering, Inc.; S.H. Creel Contracting, LLC; and HD Excavations & Utilities LLC to perform on call stormwater system and infrastructure repairs and maintenance, subject to review and approval by the City Attorney.
