**AMENDMENT NO. 1 TO THE  
AGREEMENT FOR SILVER COMET TRAIL CONNECTIONS  
WITH S.H. CREEL CONTRACTING**

This Amendment No. 1 ("First Amendment") is made and entered into this 29 day of April 2024, by and between the CITY OF POWDER SPRINGS, GEORGIA, a municipal corporation of the State of Georgia (the "City"), and S.H. CREEL CONTRACTING ("Contractor"); heretofore referred to jointly as the "Parties."

WHEREAS, the Parties entered into an Agreement for Vendor/Contractor Services on March 27, 2024 (the "Agreement"); and

WHEREAS, the Agreement provides for connections to the Silver Comet Trail near Dillard Street and near the skatepark feature; and

WHEREAS, the Parties desire to amend the Agreement to remove the connection near Dillard Street to further reassess surface material and to add handrails to the connection near the skatepark;

NOW THEREFORE, the City and Contractor agree that the Agreement shall be amended to remove the connection at Dillard Street and to add handrails to the connection near the skatepark feature for a new contract amount of \$19,000.

This First Amendment together with the Agreement constitute the entire agreement between the Parties and supersede all prior oral and written understandings with respect to the subject matter set forth herein. Unless specifically stated all other terms and conditions of the Agreement shall remain in full force and effect.
