Variance Application: Table 2-4 (Dimensional Requirements for Mixed Use and Non-residential Zoning Districts), Section 12-52 (Front Landscape Strip) and Section 4-266 (Self-Service Storage Facility, Climate-Controlled) of the Unified Development Code to construct a self-service storage facility along CH James

Parkway on property located within the Community Retail Commercial (CRC) zoning district within Land Lots 825.

Special Use denied for Self-Service Storage facility. Therfore no vote required for variance. However members provided recommendation to the Mayor and Council as follows:

- 1) requesting to reduce the setback of the building from 50 feet to 40 feet along the east property line.
- 2) Provide an additional 25% landscpare buffer in addition to what is required.
- 3) Lower the grade to allow from building height similariries.
- 4) To require only Brick Veneer
