

COBB COUNTY DEPARTMENT OF TRANSPORTATION AMENDMENT TO COBB FRAMEWORK AGREEMENT

Project Nos. X2312 and X2325 AMENDMENT NO. 1

WHEREAS, the City of Powder Springs (CITY) and Cobb County, Georgia (COUNTY), hereinafter collectively referred to as the parties, entered into a Cobb Framework Agreement (the "Agreement") on February 19, 2019, for services associated with Powder Springs Road at Flint Hill Road/Pine Grove Drive ("Project X2312") and Powder Springs Road at Deercreek Drive ("Project X2325"), Project X2312 and X2325 collectively referred to in this Cobb Framework Agreement as the "PROJECTS"; and

WHEREAS, the parties originally anticipated the total cost for the PROJECTS to be \$1,050,000 and agreed upon a funding split, with the COUNTY contributing 52% (\$550,000) and the CITY contributing 48% (\$500,000); and

WHEREAS, the design, ROW acquisition, and construction are complete for the PROJECTS; and

WHEREAS, the total costs for Project X2312 are now known to be \$3,190,823; and

WHEREAS, the total costs for Project X2325 are now known to be \$62,051; and

WHEREAS, the parties agree that the financial contributions for the PROJECTS shall be specifically set forth by this amendment to the Agreement.

NOW THEREFORE, for and in consideration of the mutual benefits and obligations flowing each to the other, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to amend the Agreement as follows:

1. Section 14 is hereby amended by revising the maximum financial contributions of each party for the PROJECTS as follows:

For X2312: COUNTY - \$1,517,733 CITY - \$1,673,090

For X2325: COUNTY - \$32,267 CITY - \$29,784

TOTAL COUNTY - \$1,550,000 TOTAL CITY - \$1,702,874

- 2. Exhibit B of the Agreement is hereby deleted in its entirety and replaced with the new Exhibit B attached hereto to reflect the funding distribution amounts for the PROJECTS.
- 3. All other terms and conditions of the Agreement not changed by this Amendment shall remain in full force and effect.
- 4. This First Amendment shall become effective upon the date this Amendment is signed by both parties ("Effective Date").
