This agreement is between Community Showcase Banners, LLC an affiliate company of CGI Communications, Inc. D/B/A CGI Digital and the City of Powder Springs, GA and shall remain in effect from the date it is signed by both parties until the completion of the one (1) year of banner display, as described herein.

Community Showcase Banners shall provide the following:

- A minimum of 25 custom- graphic vinyl banners for all permissible poles
- Business sponsors featured on the bottom 30% of the banner
- Artwork, design and size customized to meet your community's specifications (standard size 30" x 72")
- All brackets, hardware, installation and maintenance
- Replace any damaged or faded banners at no cost to the city
- Quantity of banners determined by number of sponsor participants
- Duration of sponsor participation will be one (1) year with the option to renew each following year of the agreement
- Sponsorship fulfillment including all related aspects of marketing, production, and printing
- The City of Powder Springs, GA will assume no cost or liability for the sales, production, placement, and maintenance of the banners for this project and CGI will indemnify and hold harmless the City from and for any and all claims related to the same.
- Removal of all banners and hardware at the end of the term and upon the City's request if the agreement is not renewed or a new agreement is not entered into.

The City of Powder Springs, GA shall provide the following:

- Letter of introduction supporting the program on your organization's letterhead
- The right for Community Showcase Banners to use organization's name in connection with the preparation, production and marketing of the program set forth herein only
- Identification of, access to, and permission to utilize the preferred pole sites for accurate banner placement
- Identification of and access to a minimum of 25 poles for banner placement

This Agreement shall have an initial term of one (1) year and shall automatically renew one time only for an additional one-year term, unless canceled by either party as provided below. After the renewal term, this Agreement shall automatically expire and shall not renew further. City's Right to Cancel: The City may cancel this Agreement for the renewal term by providing written notice to the Provider at least sixty (60) days prior to the end of the banner display for the initial term. If no such notice is given within this period, the Agreement shall be considered renewed for that single additional one-year term, after which it shall expire. Provider's Right to Cancel: The Provider may cancel this Agreement by providing express written notice of its intent to cancel within sixty (60) days after the commencement of the banner display for the initial term.

We, the undersigned, understand the above information and have full authority to sign this agreement.
