- This Agreement shall remain in effect until terminated by either party upon 60 days prior written notice. Termination shall not affect the remedies or covenants of the parties set forth herein with respect to waste which has been delivered prior to the effective date of termination. The price and frequency for servicing of the waste shall be set forth above. During the term, Environmental Remedies shall be Customer's exclusive grease trap service provider. Upon thirty (30) calendar days written notice to Customer, Environmental Remedies may increase or decrease the price established for servicing the waste. If any service to which such price changes apply is performed by the Environmental Remedies more than thirty (30) days after Customer's receipt of such notice, Customer shall be deemed to have accepted such price changes. If Customer requests additional services or has provided inaccurate information when requesting a quotation, including the size, number and conditions of the grease traps requiring service, pricing is subject to increase. Waiting time over 15 minutes will be charged at \$40.00 per 15 minutes. If the Customer wishes to cancel its scheduled pickup and does not contact Environmental Remedies during regular business hours (Monday thru Friday, 8 a.m. to 5 p.m.) at least 24 hours in advance of the scheduled pickup time, or the Customer is not at the work site within 15 minutes of the scheduled pickup time, a \$125.00 rescheduling fee will be assessed.
- Environmental Remedies warrants that it has all permits or approvals which are required for servicing the waste.
- Payments by credit card will be charged to the card immediately upon performance of services. For services provided on net 30-day terms, payment is due within thirty (30) days of the invoice date. In the event Customer fails to make payment when due on any valid invoice, an amount equal to 1.5% per month will be added to all amounts outstanding for more than thirty (30) days. Customer is responsible for notifying Environmental Remedies of any question concerning an invoice. In addition, Customer shall be responsible for any collection agency or legal fees incurred by Environmental Remedies in collecting payment of an invoice.
- Environmental Remedies is, and shall perform this Agreement as, an independent contractor and as such, shall have and maintain complete control over all of its employees and operations. Environmental Remedies is not liable for any damage to the pavement, parking lot or driving surface resulting from its truck or equipment used in servicing the Customer.
- Customer gives authorization to Environmental Remedies to provide services per the above schedule without obtaining a signature on the Commercial Waste Manifest.
