**A RESOLUTION APPOINTING MARCEL KENNEDY AND RAJA ANTONE TO THE DEVELOPMENT AUTHORITY OF POWDER SPRINGS; APPOINTING KELLY FISK AND TAYLOR RUFUS TO THE PLANNING AND ZONING COMMISSION; APPOINTING DAREN PATRICK TO THE CULTURAL AFFAIRS AND ARTS COMMISSION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**

**WHEREAS** the City desires to appoint Raja Antone to DAPS to the position occupied by Kent Shelton whose term expires 8/17/23; and


