A RESOLUTION ACCEPTING AND APPROVING THE BID QUOTATION FROM INTERNATIONAL BUSINESS SOLUTIONS IN THE AMOUNT OF \$37,400.00 TO REPAIR STORMWATER INFRASTRUCTURE; AUTHORIZING THE TEMPORARY CLOSURE OF ROADS AND USE OF TRAFFIC CONTROL MEASURES NECESSARY TO EFFECTUATE SAME; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Powder Springs (the "City") has identified deteriorated or defective stormwater infrastructure that requires repair and maintenance work;


WHEREAS, the City solicited and received quotes to perform the stormwater repair and maintenance work and International Business Solutions was deemed to be the lowest and most responsive bidder;

WHEREAS, the City desires to accept and approve the bid from International Business Solutions and to authorize any temporary road closure and traffic control measure that may be required to complete the work;

NOW THEREFORE, be it hereby resolved by the Mayor and Council of the City of Powder Springs that the quotation of International Business Solutions to perform repair and maintenance work on the City's stormwater infrastructure at a cost of \$37,400.00 is accepted and approved, and the Mayor is authorized to execute an agreement to effectuate same after review and approval by the City Attorney.


