A RESOLUTION AUTHORIZING THE TEMPORARY CLOSURE OF CERTAIN LOCAL ROADS AND TRAIL TO FACILITATE THE FIDO FUN RUN HOSTED BY RESURGENS ORTHOPAEDICS; AUTHORIZING THE TEMPORARY CLOSURE CERTAIN LOCAL ROADS TO FACILITATE THE 2017 CHRISTMAS PARADE HOSTED BY THE CITY OF POWDER SPRINGS; AUTHORIZING THE TEMPORARY CLOSURE OF CERTAIN LOCAL ROADS AND TRAIL TO FACILITATE THE 2017 REINDEER RUN HOSTED BY THE CITY OF POWDER SPRINGS; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Powder Springs (the "City") has received a temporary event permit application for a 5K event on October 14, 2017 at 10:00am, which will require the temporary closure and use of local roads and city trail;

WHEREAS, the run is an annual fundraising event known as the Fido Fun Run conducted by the Resurgens Orthopaedics to benefit the Resurgens Charitable Foundation, whose mission is to promote active lifestyles for peoples all ages and abilities;

WHEREAS, the event is open to runners and walkers of all ages and abilities and canines, and the City desires to accept and approve the application to use local roads and trail for the event;

WHEREAS, the City will conduct the Storybook Christmas Parade on December 1, 2017 at 6:00 p.m., beginning at the Powder Springs Library and ending on the town square for the annual Tree Lighting event, necessitating the temporary closure of local roads;

NOW THEREFORE, BE IT HEREBY RESOLVED by the Mayor and Council of the City of Powder Springs that the temporary closure and use of Lucille Trail, Jackson Way, Cemetery Street, Old Lost Mountain Road, and Dallas Powder Springs Road and Florence Road is hereby approved for the Fido Fun Run on October 14, 2017 between 8:00 a.m. and 12:00 p.m.;

BE IT FURTHER RESOLVED that the temporary closure and use of Atlanta Street, Old Austell Road, Marietta Street, Old Lost Mountain Road and Jackson Way is hereby approved for the Storybook Christmas Parade on December 1, 2017 from 5:00 p.m. and 8:00 p.m.. This Resolution shall become effective immediately upon adoption.




