

RESOLUTION 2023 - 058

A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT WITH WASTE PRO OF GEORGIA, INC. TO HAUL AND PURCHASE SEPARATE RECYCLED MATERIALS FROM THE CITY RECYCLING CENTER; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS the City of Powder Springs (“City”) previously approved the establishment of a recycling drop off center at its Public Works facility to replace the curb-side pickup program that was terminated by the recycling provider; and

WHEREAS the City solicited and obtained a proposal from a qualified provider for the hauling and purchasing of separated recyclable materials from the Powder Springs recycling center to a nearby collection facility, including a cost proposal for the removal and transportation of the materials as well as a purchase price rate for the materials; and

WHEREAS the Waste Pro of Georgia proposes to haul and purchase PET/HDPE bottles, aluminum cans, and metal/tin cans and transport to nearby collection facilities; and

WHEREAS, for PET/HDPE bottles, the vendor proposes to haul a 48’-53’ trailer for \$160 per pick-up plus charge \$185 monthly rental, and purchase the material for market rate; and


WHEREAS, for aluminum cans, the vendor proposes to haul a 30 yard open top dumpster for \$204 per pick-up plus charge \$92 monthly rental, and purchase the material for market rate; and


WHEREAS, for metal/tin cans, the vendor proposes to haul a 30 yard open top dumpster for \$204 per pick-up plus charge \$92 monthly rental, and purchase the material for market rate; and


WHEREAS the City desires to accept the proposal from Waste Pro of Georgia, Inc. to collect and remove said items and to continue seeking proposals to collect and remove cardboard, paper and glass in order to reduce the amount of waste being diverted to the solid waste stream; and


NOW THEREFORE, BE IT HEREBY RESOLVED by the Mayor and Council of the City of Powder Springs that it approves and authorizes the Mayor to execute an agreement with Waste Pro to collect and remove recyclable materials from the City’s recycling drop off center for the rates contained in their proposal, subject to review and approval by the City Attorney.






