In consideration of being allowed to participate in The Silver Comet Races 19th Annual Half Marathon, 8th Annual Marathon & Fun Run on October 26, 2019 ("EVENT") and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned represents and agrees as follows: I agree, for myself and for my personal representatives, heirs, and next of kin, to hereby release, and discharge from any and all liability and waive any claim which I might state against Silver Comet Races, Dana Greene, Kroger and each of its subsidiaries, affiliates and their respective officers, employees, sponsors, independent contractors, volunteers, representatives, successors & assigns (hereinafter Silver Comet Race Parties) as a result of any injury, including death, sustained by me or loss to my property while participating in this EVENT, whether caused by negligence, breach of warranty (express or implied) or otherwise and whether foreseen or unforeseen, while I am traveling to or from, or participating in the EVENT or resulting from my acceptance or use of any prizes awarded in connection therewith.
