

RESOLUTION NO. 2023 - 120

**A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE CERTAIN AGREEMENTS FOR PROFESSIONAL SERVICES SUBJECT TO THE FISCAL YEAR 24 BUDGET AMOUNTS; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Powder Springs (the “City”) has a need for professional services related to information technology, communications and marketing, grant writing, economic development, code enforcement, building services, human resources, lobbying, annexation and procurement, zoning and development, auditing and stormwater;

**WHEREAS**, the City desires to renew professional services with its current providers in accordance with its operating and capital budgets;

**NOW THEREFORE**, be it hereby resolved by the Mayor and Council of the City of Powder Springs that it authorizes the Mayor to execute agreements for certain professional services for FY24, subject to review and approval by the City Attorney and operating and capital budget amounts for the following: (1) purchasing and procurement services Joe Tommie in the amount of \$15,000; (2) meeting and streaming, marketing website services and business videos for Above the Cloud for \$16,388, \$12,600 and \$15,500, respectively; (3) public information and communication services provider Gargis Consulting in the amount of \$62,920; (4) actuarial services with Southern Actuarial for \$6,000; (5) events, marketing and advertising provider Sherry Garner through the Vy Group in the amount of \$29,328; (6) downtown economic development provider Ann Arnold in the amount of \$15,600; and (7) economic development and annexation services with BH3 in the amount of \$66,000; (8) personnel and human resources services with Innovative Outsourcing in the amount of \$15,000; (9) grant writing services with the Brewer Agency in the amount of \$22,500; (10) code enforcement and building services with Safebuilt for an amount of \$288,000 and \$200,000, ; (11) zoning fiscal impact analysis with Gary Mongeon at Bleakly Advisory for \$22,000; (12) zoning code and design with TSW for \$40,000 and BH3 for \$28,800; (13) audit services with Mauldin & Jenkins for an of \$35,000; (14) stormwater management and engineering services for an amount of \$50,000 each; (15) development engineering review with Croy and Dewberry for \$15,000 and \$10,000, respectively. This resolution shall be effective July 1, 2023.
