**A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT WITH COBB COUNTY FOR USE OF POWDER SPRINGS PARK BALLFIELDS FROM WHICH TO CONDUCT A FIREWORKS SHOW ON JULY 4, 2021; APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE AN AMENDMENT TO THE CONTRACT WITH RICKETS RHODES EVENT PROMOTER RELATING TO CARNIVAL OPERATIONS AND EQUIPMENT IN POWDER SPRINGS PARK AS PART OF SPRINGSFEST ON THE 4<sup>TH</sup> BETWEEN JULY 1 AND JULY 4 PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Powder Springs (“City”) has authorized SpringsFest on the 4<sup>th</sup> in observance of July 4 Independence Day Celebration;

**WHEREAS**, SpringsFest on the 4<sup>th</sup> includes a carnival from July 1 to July 4 and a fireworks display on July 4, and the City sought and received authorization from Cobb County to use Powder Springs Park from which to conduct the fireworks display and carnival;


**WHEREAS**, as part of the authorization, Cobb County requires execution of an Intergovernmental Agreement (“IGA”) governing the use of Powder Springs Park, which the City desires to accept, approve and include the IGA within the SpringsFest on the 4<sup>th</sup> contract;

**NOW THEREFORE, BE IT HEREBY RESOLVED** by the Mayor and Council of the City of Powder Springs that it approves and authorizes the Mayor to execute an Intergovernmental Agreement with Cobb County governing use of Powder Springs Park for SpringsFest on the 4<sup>th</sup>, after review and approval by the City Attorney.

**BE IT FURTHER RESOLVED**, that said IGA shall become a part of the agreement with Ricketts Rhodes for SpringsFest on the 4<sup>th</sup> and the Mayor is authorized to execute an amendment to said agreement, after review and approval by the City Attorney. This Resolution shall be effective upon adoption.
