Dear Chief Bailey,

In consideration of providing the Powder Springs Police Department accommodations for training at Governors Gun Club, LLC, we are pleased to provide the following proposal:

- Governors Gun Club will provide the Powder Springs Police Department with GGC Shooter Memberships as a benefit to their officers and staff as the department sees fit.
- Governors provides a safe and professional atmosphere with features not collectively offered at any other local range. The Powder Springs location most convenient to the district offers the following:
  - **Firearm Training**
    - 1 Dynamic tactical range bay
    - 16 rifle rated lanes
    - Fully programmable cableless automated high-speed turning target system
    - Turning target system to accommodate shoot / tease / No shoot scenario
    - Three stage pre-filter and HEPA filter ventilation system providing lead free heated and cooled shooting environment.
    - Sound absorbing noise abatement range environment
    - Blue or red light strobe system
    - Low light range lighting for night site and low light exercises
  - **Classroom**
    - Accommodates 20 comfortably
    - OH Projector and surround sound
    - Interface: Wi-Fi Internet / DVD / Laptop PowerPoint Ready / DirecTV



- Each Membership will carry the full benefits of Governors Gun Club GGC Shooter as outlined below. These benefits are available anytime during normal business hours.
  - Access to any Governors Gun Club location
  - Free range time on pistol and rifle ranges
  - Free eye and ear protection rental
  - Discounts on ammunition and accessories
  - Priority range placement
  - Free full-auto firearm rental on birthday
  - Reduced rates on GunTech firearm cleaning services
  - Discounted archery range access
  - Discounts on gun smith and bow tech services
- Memberships can be upgraded by the individual holder to Platoon Membership (\$150) or Full Metal Jacket Membership (\$400).
- Powder Springs Police Department will be provided reserved private access to the tactical bay (8 Rifle rated lanes) and classroom at a rate of 1 hour per month, for every 10 memberships. Reserved hours are typically Monday through Friday, 7:00am to 5:00pm. Segments will be reserved for a minimum of 4 hours.
- Powder Springs Police Department will be provided 1 Full Metal Jacket upgrade for every 15 memberships. Full Metal Jacket memberships provide convenient access for management and command staff to use lounge and conference areas for meetings.
- Governors can provide storage of practice ammo for Powder Springs Police Department. Governors will provide monthly inventory counts and records of distributions to department personnel.
- Memberships will be reciprocal access and benefits at any Governors Gun Club location.
- Department Memberships can be transferred from former officers to newly recruited officers during the 12-month membership period at no additional cost.
- At no time during the contract period will memberships be refunded due to variable drop in number of Department officers or staff. Additional memberships above the original contract amount can be added at prorated amount based upon remaining term of agreement.
- Governors can schedule Georgia Post Certified instructors for officer qualification by appointment. This service is billed to the department monthly by the hour.

This proposal provides for a 12-month contract period for an LE Department membership. Invoice for 12-month contract will be provided within 48 hours of execution of proposal. Payment in full for membership is due within 30 days of receipt of invoice. Individual membership agreements can be



provided and executed by Powder Springs Police Department staff as the department deems convenient and proper.

Department Rates are as follows:

- *12 Month inclusive membership as provided above is \$220.00 per officer or per department staff personnel.*

Governors Gun Club anticipates that this will provide a significant savings in officer and staff travel time. Travel time should be significantly less with Governors Gun Club in a central West Cobb County location. This convenience should provide a significant savings to the department through officer and staff trip time and vehicle mileage over other location options. The convenience of the Powder Springs location, and a second location in Kennesaw should encourage and provide a safer more practiced department through added convenience.

Lastly as a consideration, many departments find that a Governors Gun Club membership for their officers provides an additional employment resource and benefit as part of the departments employee benefit package.
