**AN ORDINANCE TO AMEND THE LIST OF ROADWAYS APPROVED FOR THE USE OF SPEED DETECTION DEVICE WITHIN THE CITY OF POWDER SPRINGS; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES**

**WHEREAS**, the City of Powder Springs (City) Police Department previously applied for approval for the use of speed detection devices on certain roads;

**WHEREAS**, the Georgia Department of Transportation has reviewed the application and identified the roads where the speed detection device may be used under certain circumstances, including the City's modification of requested speeds;

**WHEREAS**, in order to use speed detection devices within the City, the Mayor and Council are required to adopt an ordinance identifying the roads and speeds covered by the State's speed detection device permit, and the City desires to amend the current list and adopt the attached list in its place;

**NOW THEREFORE**, the Council of the City of Powder Springs hereby ordains that the list of roadways and speeds approved for the use of speed detection devices shall be as shown on the attached Exhibit A.

**BE IT FURTHER ORDAINED** that all ordinances and parts of ordinances or other resolutions or regulations in conflict herewith are hereby repealed, and this ordinance shall become effective immediately upon execution by the Mayor and City Council.
