

RESOLUTION NO. 2018-047

A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH KNINE ALLSYSTEMS TO INSTALL A CONVERGED ACCESS CONTROL SYTSEM AT THE FORD CENTER RECEPTION HALL FOR AN AMOUNT OF \$6792.86; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Powder Springs (the "City") manages the rental and use of the Ford Center Reception Hall for private and public events, which events often require the scheduling of staff to close the facility with resulting overtime expenses;

WHEREAS, the Parks and Recreation department has examined alternatives for securing the facility after hours and recommends the installation of a converged access control system that would secure the facility at the conclusion of the event without assigning an individual to report after hours to close and lock the facility;

WHEREAS, the police officers on duty following the conclusion of the event will check the facility during their shift to confirm that the facility is secured and locked;


NOW THEREFORE, BE IT HEREBY RESOLVED by the Mayor and Council of the City of Powder Springs that it approves and authorizes the installation of a converged access control system at the Ford Center Reception Hall to automatically secure said facility following conclusion of an event, and authorizes the Mayor to execute an agreement with Knine AllSystems for an amount of \$6,792.86, subject to review and approval by the City Attorney. This resolution shall become effective immediately upon adoption.
