A RESOLUTION ACCEPTING AND APPROVING A CHANGE ORDER FOR CERTAIN PORCH REPAIRS TO THE OLD MUSEUM FACILITY LOCATED AT THE POWDER SPRINGS PARK FOR AN AMOUNT OF \$4,304.77; AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT FOR SAID REPAIR; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Powder Springs (the "City") previously approved repairs and upgrades to the front porch of 3901 Brownsville Road, otherwise known as the old museum location;

WHEREAS, the Building Official and Fire Marshal notified the City of additional work to be performed to properly allow public access under the applicable commercial building codes;

WHEREAS, the City solicited and obtained quotes to complete the repairs and upgrades to the front porch access, and it desires to accept the quote in the amount of 4304.77;

BE IT THEREFORE RESOLVED by the Council for the City of Powder Springs that the cost proposal for additional work in the amount of \$4304.77 to properly repair and upgrade the front porch and ramp per commercial standards is hereby approved, and the Mayor is authorized to execute a change order to effectuate same, subject to review and approval by the City Attorney. This Resolution shall be effective immediately upon adoption.




WHEREAS, the Fire Marshal notified the City of the requirements to repair and upgrade the front porch to allow public access under the applicable building codes relating to accessibility;




