**A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH TUCKER GRADING & HAULING TO CLEAR AND INSTALL AN OPEN SPACE AREA ALONG THE SILVER COMET TRAIL LINEAR PARK FOR AN AMOUNT OF \$34,815.00; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Powder Springs (the "City") has completed various phases of the Silver Comet Trail Linear Park ("linear park") for the use and enjoyment by residents and visitors;

**WHEREAS**, while the City is securing funding for the next full phase of the linear park, it desires to clear and make available for trail users an open space adjacent to the basketball court for free play, picnics and passive use;


**WHEREAS**, the City solicited and obtained quotes to provide an open space for passive use and enjoyment with picnic tables and benches, and it desires to accept the quote submitted by Tucker Grading & Hauling;


**NOW THEREFORE, BE IT HEREBY RESOLVED** by the Mayor and Council of the City of Powder Springs that it approves and authorizes the Mayor to execute an agreement with Tucker Grading & Hauling for an amount of \$34,815.00 to provide an open space for passive recreational enjoyment along the Silver Comet Trail Linear Park, subject to review and approval by the City Attorney. This resolution shall become effective immediately upon adoption.


