AN ORDINANCE TO AMEND THE BUDGET FOR FISCAL YEAR 2020 RELATING TO THE RECEIPT AND APPROPRIATION OF CDBG MONIES, THE BUDGETED USE OF FUND BALANCE FOR PUBLIC SAFETY SEIZURE EXPENDITURES, THE TRANSFER OF FUNDS FROM PUBLIC WORKS SALARIES AND WAGES TO THE STORMWATER FUND TO COVER THE CROY STORMWATER MANAGEMENT WORK PREVIOUSLY APPROVED BY COUNCI, THE RECEIPT AND ALLOCATION OF DOLLARS PAID TO THE CITY FOR THE DOWNTOWN PARK, AND THE TRANSFER OF FUNDS FROM PUBLIC WORKS BUILDING MAINTENANCE TO THE CAPITAL PROJECTS FUND FOR THE PURPOSE OF INSTALLING PHYSICAL BARRIERS IN THE RECEPTION AREAS AS A RESULT OF THE NOVEL CORONAVIRUS; TO REPEAL CONFLICTING ORDINANCES; TO ESTABLISH AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City desires to amend the FY20 budget to record the annual budget for federal seizures;

WHEREAS, the City has received funds from Cobb County Community Development Block Grant program for use at the Linear Park and at the Senior Center and desires to amend the Fiscal Year 2020 budget to receive and appropriate said funds for said projects;

WHEREAS, the City previously engaged Croy Engineering to provide stormwater services and complete the annual stormwater report using dollars from stormwater salaries for a position that remains unfilled, and the City desires to complete the budget amendment to transfer those funds from the public works budget in the general fund to the stormwater fund;

WHEREAS, the City has received funds from private property owner to offset the costs of downtown park construction related to construction changes needed to accommodate the owner's property improvements;

WHEREAS, the planned renovations to the reception areas of City Hall and Community Development will be completed over two fiscal years resulting in the need to transfer dollars from public works building maintenance to the capital projects fund;

NOW THEREFORE, the Mayor and Council of the City of Powder Springs hereby ordain that the budget ordinance for the fiscal year 2020 be amended as provided in the attached;

BE IT FURTHER ORDAINED, that all ordinances and parts of ordinances in conflict herewith hereby repealed, and this ordinance shall become effective immediately upon execution by the Mayor and City Council.




