

RESOLUTION NO. 2022 - 040

A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH D&N TREE SERVICE FOR AN AMOUNT OF \$3850 TO REMOVE A TREE FROM PUBLIC RIGHT OF WAY ON JACKSON WAY EXTENSION; APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH C&M TREE SERVICE AND GENERAL CONTRACTING FOR AN AMOUNT OF \$2500 TO REMOVE AND TRIM CERTAIN TREES FROM PUBLIC PROPERTY ON JACKSON WAY; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Powder Springs (hereinafter “the City”) Public Works Department examined the condition of trees located on public property adjacent to commercial and residential structures and public parking and found a tree dying and in danger of falling and causing damage to private property and or injury;

WHEREAS, the Public Works Department solicited and obtained quotes to remove the tree, and the City desires to accept and approve the lowest responsive quote submitted by D&N Tree service to perform said work;

WHEREAS, Georgia Power will be rerouting electrical service on Jackson Way and installing poles and wires that require the removal and trimming of certain trees;

WHEREAS, the Public Works Department solicited and obtained quotes to remove and trim trees to accommodate the utility relocation, and the City desires to accept and approve the lowest responsive quote submitted by C&M Tree Service and General Contracting (“C&M Tree Service”) to perform said work;


NOW THEREFORE, BE IT HERBY RESOLVED by the Mayor and Council of the City of Powder Springs that it accepts approves the quote submitted by D&N Tree Service in the amount of \$3850 to remove a dying tree from public property located on Jackson Way Extension and authorizes the Mayor to execute an agreement with D&N Tree Service to effectuate same, subject to review and approval by the City Attorney.

BE IT FURTHER RESOLVED, that it accepts and approves the quote submitted by C&M Tree Service in the amount of \$2500 to remove and trim trees from public property located on Jackson Way to accommodate a utility relocate and authorizes the Mayor to execute an agreement with C&M Tree Service to effectuate same, subject to review and approval by the City Attorney. This resolution shall be effective immediately upon adoption.






