

RESOLUTION NO. 2025 - 117

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT FOR CERTAIN CONTINUED AND ENHANCED PROFESSIONAL SERVICES SUCH AS AUDIO VISUAL, COMMUNICATIONS, ECONOMIC DEVELOPMENT, ACTUARIAL ANALYSIS, MARKETING, GRANT WRITING AND PROCUREMENT; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS the City of Powder Springs (the “City”) has a need for continued professional services related to audio visual at public meetings, communications, advertising and marketing, streaming services, economic development, actuarial analysis, development and plan reviews, procurement, and grant writing, and it desires renew professional services with its current annual providers in accordance with the approved operating and capital budgets; and

WHEREAS the services described in this resolution exclude those services approved in the annual budget that are: (1) appointments made each January such as the city attorney, city building official, or city engineer; (3) multi-year contract labor agreements requiring bid solicitations such as janitorial services, landscape services, pest control and the like; or (3) one-time or specialized services such as Carl Vinson Institute or Mauldin & Jenkins.

NOW THEREFORE, be it hereby resolved by the Mayor and Council of the City of Powder Springs that it approves and authorizes the Mayor to execute agreements, if applicable, for continued professional services for FY26, subject to the approved operating and capital budget amounts for the following: (1) purchasing and procurement services with Joe Tommie for up to \$8,000; (2) communications, audio visual and streaming services for council, court, zoning commission and town hall meetings with Above the Cloud for up to \$49,780; (3) public information and communication services with Gargis Consulting in the amount of \$63,000; (4) actuarial services with Southern Actuarial for up to \$6,000; (5) advertisement and newsletter development for Vy Group for up to \$30,000; (6) downtown economic development main street consulting with Lillie Read for up to \$17,000; (7) zoning and plan review services with BH3 for up to \$30,000; (8) economic development video and social media services by Above the Cloud for up to \$32,500 and enhanced marketing and public relations services for up to \$15,000 a quarter; (9) grant writing with Fund it Forward for up to \$25,000; (10) Floodplain development review with Dewberry for up to \$30,000; (11) Stormwater consult on plan development with Croy for up to \$22,000; (12) Development Plan Fiscal Review with KB Advisory for up to \$20,000; (13) Development Plan design review with TSW for up to \$15,000; (14) Impact Fee program update with Weitz & Associates for up to \$10,000; This resolution is effective July 21, 2025.
