CUSTOMER SUPPLIED ITEMS:

All materials supplied by the customer, that are to be installed by Contracotr will be charged at the current hourly rate for installation. All items must be on site, in sufficient condition to be installed as "Like New" and in working order. Customer bears all responsibility pertaining to the condition, performance and warranties of such parts. No additional warranty will be extended to customer supplied parts, nor to items affected or attached to customer supplied parts.

MONITORING SERVICES:

Unless expressly changed in this agreement, all quotes for security monitoring require a 36 month monitoring agreement. A reduction in cost and term can be added for additional up-front cost.

AHJ/CODE REQUIREMENTS

The Authority Having Jurisdiction (AHJ) may require additional engineering, scope of work and/or equipment for this project. All change orders and additions required to meet code and/or AHJ requirements will result in additional cost beyond the scope of this estimate. All Additional Permits and Inspection Fees will be added at additional cost. The above estimate is not a contract or an invoice and is subject to change if additional parts or labor are required.

TAKEOVERS/USING EXISTING EQUIPMENT

Any existing controls, wire and/or devices to be re-used that are found to be inoperable or insufficient will be replaced at an additional cost. This includes controls with prior company's lock out codes.

CCTV/ VIDEO / CAMERAS

Remote Access to DVR and Cameras requires customer to provide usernames and passwords for router and modem access. Managed networks will require additional support from the network manager. Customer must provide active and working internet of sufficient bandwidth to ensure transmission of Video Services.

SURGE SUPPRESSION

LOUD Security highly recommends surge suppression, however even with the proper surge suppression in place does not extend warranty to items damaged by lightning or electrical surge.

ACCEPTANCE / BILLING

IMPORTANT REMINDERS

CANCEL FALSE ALARM: Call 770-427-1300 cancel a false alarm. You **MUST** know your CODEWORD!!

Once your name, property address, and code word are verified, the false alarm will be cancelled.

(Police **WILL BE** dispatched if code word is not provided!)

EMERGENCY CONTACTS: Contact our office if your emergency contacts change. These are the numbers called by the monitoring station if you cannot be reached during an alarm.

HOLD UP/DURESS CODE: Use this code **ONLY IF** you are **FORCED** into your home or business! The system will disarm as usual but will send a silent alarm to the monitoring station and police will be dispatched immediately. You will select this code during your system installation/activation.

REMODELING: Call our office **BEFORE** you begin any construction that could impact your security system. We can help determine if any changes need to be made to your system during your remodeling project.

SYSTEM MAINTENANCE: Test your system regularly to ensure it is communicating with the monitoring station. Refer to your user's manual or call the LOUD office for assistance. Notify us immediately if any trouble/fault code is display on your keypad. Keep motion detectors clear of dust and spiders as they potentially can set motion detectors off.
