

RESOLUTION 2024 - 106

A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH CLOVERLEAF CORPORATION TO SUPPLY LANE DELINEATORS FOR THE AMOUNT OF \$27,975.48 AND AN AGREEMENT WITH ARDITO CONSTRUCTION COMPANY TO INSTALL SAID DELINEATORS FOR AN AMOUNT \$13,872; AUTHORIZING THE PUBLIC WORKS DIRECTOR TO NOTIFY THE GEORGIA DEPARTMENT OF TRANSPORTATION, THE COBB COUNTY DEPARTMENT OF TRANSPORTATION AND NORFOLK SOUTHERN RAILROAD THE RAIL CROSSINGS AT FINCH ROAD, ANGHAM ROAD AND HUDDLESTON DRIVE ARE DESIGNATED QUIET ZONES PER THE GOVERNING STANDARDS AND REGULATIONS RELATING TO THE ESTABLISHMENT OF QUIET ZONES; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS the City of Powder Springs had previously determined to establish quiet zones at certain railroad crossings along Powder Springs-Dallas Road using funds from the American Rescue Plan Act as well as any grant sources that would offset the anticipated expense of establishing the quiet zone; and

WHEREAS in its research of requirements to establish a quiet zone, the Public Works Department contacted and received direction from the Georgia Department of Transportation and Federal Railroad Administration about the criteria for establishing the quiet zone, which included installation of delineators on Finch and Angham Roads; and

WHEREAS no modifications were required for the crossing at Huddleston Drive; and

WHEREAS per the applicable criteria the City solicited and obtained bids for the purchase and installation of the delineators required in order to establish the quiet zone, and the City desires to accept the sole quote from Cloverleaf Corporation to supply the delineators and the lowest responsive and responsible quote from Ardito Construction Company to install the delineators.


BE IT THEREFORE RESOLVED by the Mayor and Council for the City of Powder Springs that it approves and authorizes the Mayor to execute agreements with Cloverleaf Corporation for the purchase of delineators for an amount of \$27,975.48 and with Ardito Construction for the installation of delineators for an amount of \$13,872 using American Rescue Plan Act funds, subject to review and approval by the City Attorney.


