
**A RESOLUTION CONDITIONALLY APPROVING THE TEMPORARY CLOSURE AND USE OF A PORTION OF THE MUNICIPAL PARKING FRONTING MARIETTA STREET FOR TEMPORARY SPECIAL EVENTS ON THE FIRST AND FOURTH TUESDAY OF EACH MONTH BETWEEN MAY 9, 2023 AND OCTOBER 24, 2023 DURING THE HOURS OF 6:00PM AND 9:00PM TO ACCOMMODATE FOOD TRUCK FRENZY; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**


**WHEREAS** the City of Powder Springs (“City”) has received a temporary special event application from Special Blends Bartending to conduct the 2023 Food Truck Frenzy special event program on the 1<sup>st</sup> and 4<sup>th</sup> Tuesday of each month between May 9, 2023 and October 24m 2023 from 4:30PM and 9:00PM, in the front half of the municipal parking lot owned by the City that fronts Marietta Street, as shown on the attached Exhibit “A”; and

**WHEREAS** the City desires to accommodate the special temporary event and allow the temporary closure and use of a portion of the municipal parking lot for the 2023 Food Truck Frenzy in support of creating destinations that facilitate economic development and tourism, subject to the written notification to and acknowledgement by downtown businesses fronting Marietta Street and Broad Street of the events dates and parking restrictions, compliance with safety and traffic guidelines issued by the Chief of Police, post-event cleanup of the entire municipal parking lot by the applicants, consumption of alcohol only within the entertainment district and no alcohol sales to go, compliance with all state and local laws relating to alcohol and food sales, and submittal of the written notice and acknowledgement to the City Parks Department in advance of the first scheduled event.

**NOW THEREFORE, BE IT HEREBY RESOLVED** by the Mayor and Council of the City of Powder Springs that it authorizes the temporary closure and use of a portion of the municipal parking lot fronting Marietta Street as shown in the attached Exhibit “A” to conduct Food Truck Frenzy on the first and fourth Tuesday of each month between May 9, 2023 and October 24, 2023 during the hours of 6:00PM and 9:00PM (with setup at 4:30 pm), subject to the applicant providing security and traffic control as determined by the Chief of Police, providing for sanitation and cleanup of the entire parking lot following the event, providing written notice to and acknowledgement by the businesses fronting Marietta Street and Broad Street, complying with state and local laws relating to alcohol and food sales, prohibiting the sale of alcohol to go and restricting consumption to the entertainment district, and submitting written notices and acknowledgement of these conditions to the City Parks Department a week in advance of the first scheduled event. This resolution is effective immediately upon approval.
