

## RESOLUTION NO. 2023 - 225

**A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE AN AMENDMENT TO THE AGREEMENT WITH CROFT AND ASSOCIATES FOR ADDITIONAL ARCHITECTURAL SERVICES FOR AN AUDIO-VISUAL CLOSET IN THE NEW MUNICIPAL BUILDING IN THE AMOUNT OF \$12,000.00 AND FOR ADDITIONAL ARCHITECTURAL SERVICES RELATING TO FURNITURE, FIXTURE AND EQUIPMENT DESIGN FOR AN AMOUNT OF \$18,100.00; APPROVING AND AUTHORIZING THE FINANCE DIRECTOR TO PREPARE AN AMENDMENT TO THE FY24 CAPITAL PROJECT BUDGET TO REFLECT SAID ADDITIONAL SERVICES; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**

**WHEREAS** the City of Powder Springs (“City”) previously approved and authorized an agreement with Croft and Associates pursuant to Resolutions 2022-131 and 2023-080 to complete certain architectural and design services for the new city hall project; and

**WHEREAS** the City has requested additional services to include an Audio Visual office location and design consulting for furniture, fixtures and equipment, and Croft and Associates is willing and has agreed to provide said services for additional fees of \$12,000 and \$18,100, respectively; and

**WHEREAS** the FY24 capital projects budget includes funds for the city hall project for furniture and relocation expenses, and the City desires to allocate the funds for the additional services requested of Croft and Associates.

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Council for the City of Powder Springs that it approves and authorizes the Mayor to execute an agreement with Croft and Associates to provide additional architectural services relating to audio visual location in the amount of \$12,000 and relating to design for furniture, fixtures and equipment for an amount of \$18,100, subject to approval by the City Attorney.



**SO RESOLVED** this 4<sup>th</sup> day of December 2023.


